3. **DECLARATION OF TRUST:** This is a public charitable trust for the Objects set out in this Deed, the Settlers has transferred unto the Trust and Trustees, an initial sum of Rs. 10,000 (Rupees Ten Thousand only) ("Initial Corpus") (the receipt whereof the Trust and the Board of Trustees do and each of them have admitted and acknowledged) to have, receive and take the same subject to the use and upon the Trusts and subject to the powers, provisions, conditions, agreements and declarations hereinafter contained.

**4. NAME AND REGISTERED OFFICE, HEAD OFFICE & OTHER OFFICES:**

The Trust shall be known as the ' DR APJ ABDUL KALAM CHARITABLE TRUST '

Indian Trust Act-1882 or such other name as the Board of Trustees may from time to time determine in accordance with the power of amendment contained in this Deed and in accordance with the procedure laid down therein.

The head office of the Trust shall be situated at **Purba Medinipur** and the Board of Trustees may decide on the location of the head office at any place under **Purba Medinipur** District and change the same, from time to time, at their discretion. The Regional office of the Trust shall be situated at Capital Area of every states and the Board of Trustees may decide on the location of the Regional office at State Capital Area and change the same, from time to time, at their discretion.

5.2 **Main Focus :-** Our project aims to provide Holistic Education, Various type of Social Welfare Activity, Primary and Vocational Education and various youth leadership programs for sustainable living to underprivileged and economically weaker community within the Purba Medinipur District and Next All India

**Other Objects of the Trust are:**

- (i) To acquire, establish, start, aid, run, maintain or manage School and all activities related to schools, studies, all activities of School and Training Institute, residential and non-residential hostels, coaching centers and vocational training centers and later plans to make other schools colleges or universities.
- (ii) To Empowering Economically Backward Women Through Free Training .There Will Be Provision Of Cooperation And Training In Various Types Of Small Scale Business Through Ngos .
- (iii) To acquire, establish, start, aid, run, maintain or manage educational institutes, Establish Vocational Training, Para Medical Training Institute, Computer Training, Ayurveda Training Institute, Hospital, Nursing Home, College, University and Libraries for the benefit of the public especially for the poorer section of the Society.
- (iv) To provide free medical aid and sanitation rendering service to the poor people.
- (v) To acquire, establish, start, aid, run, maintain or manage charitable dispensary, first aid centre, children's clinic, eye clinic, family welfare centre, various immunization camp, blood donation camp from time to time to generate awareness amongst people suffering from Thalassaemia, Cancer, HIV/AIDS and various disease etc.
- (vi) To organize ambulance for free rendering service to needy patients.
- (vii) To organize different kind of sports and cultural programmers & festivals.
- (viii) To establish friendly relations and co-operation amongst the voluntary organizations/NGOs and every sections of Society.
- (ix) To health Empowerment & development of child, adolescent, old age and disabled persons.
- (x) To fight against any kind of corruption by the democratic way.




